

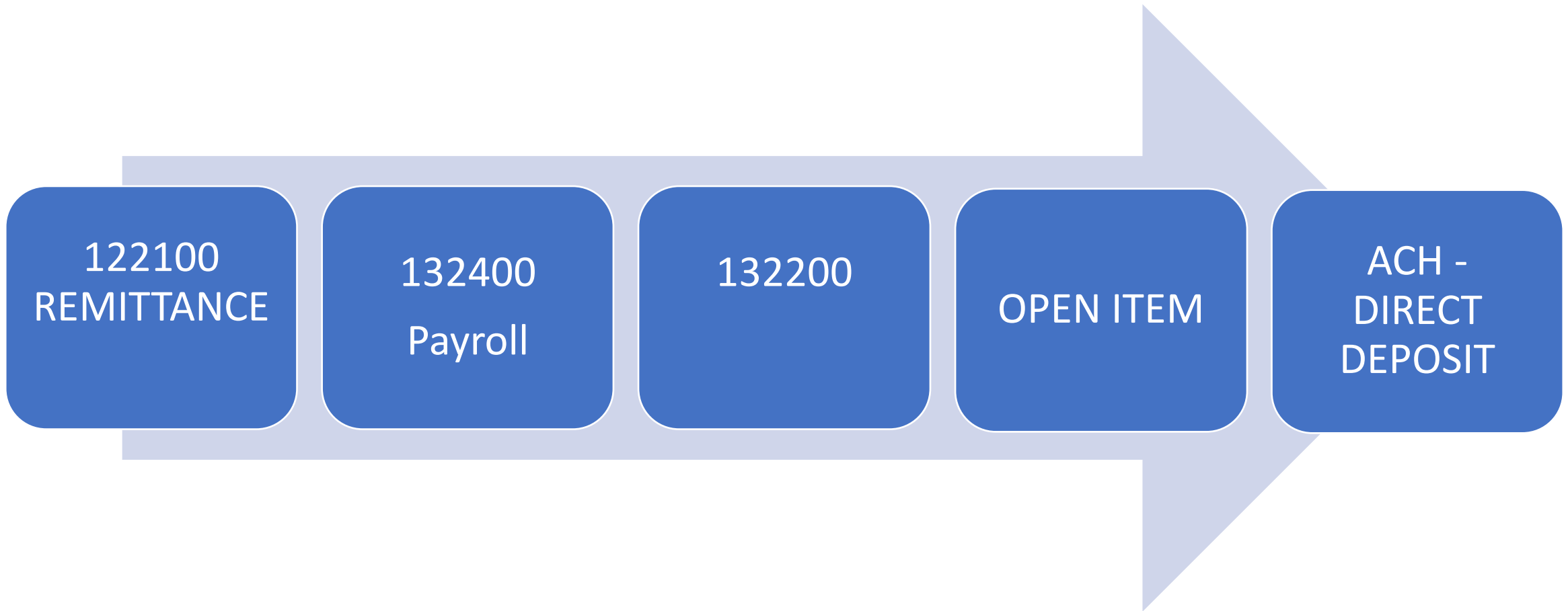

- ❖ (Automated Clearing House) are electronic payments.
- ❖ Direct Deposit (payroll payments to employees)
- ❖ Direct debit (collection from the entities account)
 1. Payroll Direct deposit, payment to employees.
 2. Payroll Direct Debit, collection for payroll payment for the pay period.
 3. Remittance Direct Debit, collection for monthly remittance.
 4. Misc. Direct Debit, all other charges as an example: youth billing, liability and property insurance, property tax.
